Chair Keesling opened public comments for the Consent Agenda item. With no members of the public wishing to speak, public comments were closed.

DEPARTMENT REPORTS

2. Spring/Summer 2020 Community Services Planned Programs

Community Services Manager Earnest presented the staff report for the review of the Spring/Summer 2020 Community Services programming. The item was discussed at the

meeting of February 11, 2020 and was requested by the Commission to bring the item with additional information relating to the proposed aquatics programming.

Several programming options were discussed with the emphasis of balancing public participation, staff and facility scheduling, and budget availability.

There were no members of the public in attendance for public comment.

Chair Keesling offered an idea to promote fun swim to learn to swim customers.

Community Services Manager Earnest explained participation in offered programming will be monitored and modified if needed.

Commissioner Staehle inquired on the current and proposed programming schedule.

Vice Chair Rauch inquired on the minimum participation required to offer Jr. Lifeguarding instruction and what the cost recovery would look like. Rauch noted he was concerned about going in at 100% without testing the need and available staffing.

Commissioner Melby inquired on the proposed increase in fun swim participants.

Community Services Manager Earnest explained that if Option A programming is being considered for next year, the Commission might consider offering this year for continuity.

Chair Keesling spoke favorably on the consistent programming with Option A.

Commissioner Staehle requested clarification on additional programming for the proposed \$20,000 increase and spoke of concern on the timing of late-day programming.

Commissioner Melby spoke favorably of the later learn to swim session offerings.

Community Services Manager Earnest explained that fun swim had been offered a couple of years ago 5:30 - 7:30 p.m. and was not popular due to the dinner hour.

Commissioner Melby inquired on the timing of the completion of the new pool.
