

FIRST AMENDMENT TO THE AGREEMENT FOR TOWN SEWER LATERAL CONNECTIONS BETWEEN THE TOWN OF YUCCA VALLEY, A MUNICIPAL CORPORATION (TOWN), AND ACTION PUMPING INC, (CONTRACTOR) DATED APRIL 16, 2017

RECITALS

1. On April 16, 2017 TOWN and CONTRACTOR entered in an Agreement for the provision of Installation of a sewer lateral from the existing HDWD sewer cleanout at the street to the existing sewer cleanout at the following locations: 6403 Goleta Ave., 6414 Goleta Ave., 6405 Avalon Ave., 6411 Avalon Ave., 6414 Hermosa Ave., 58398 Barron Ave., Paradise Park Restroom, 58928 Business Center Dr. (Community Development Building), and Install backflow prevention device (the "Agreement").
2. The Agreement provides for funding of installation of a sewer laterals and backflow prevention devices at specified locations.
3. This Amendment provides for an increase in the amount of funding from \$64,333 to \$121,813, an increase of \$57,480.

That certain Agreement for Town Sewer Lateral Connections between the TOWN and CONTRACTOR dated April 16, 2019 and attached hereto is amended in the following respects only:

Article 1. "WORK OF CONTRACTOR" Agreement Section 1.1 pertaining to "Scope of Work" attached Exhibit A is amended to include additional locations and work as follows:

- l) Contractor will perform the following work:
 - A. Installation of a sewer laterals from the existing HDWD sewer lateral/connection point at the street to the existing sewer cleanout at the following locations and abandonment of the existing septic systems:
 - ix) **Change slope of existing sewer lateral at 58928 Business Center Dr. (Community Development Building) and repair the street. (Does not include abandonment of existing septic system)**
 - x) **56711 Twentynine Palms Highway (Welcome Center) to install a dry connection. (Does not include abandonment of existing septic system)**

Article 2. "COMPENSATION AND METHOD OF PAYMENT" Agreement Section 2.1 pertaining to "Contract Sum" is hereby amended to read as follows:




Subject to any limitations set forth in this Agreement, Town agrees to pay Contractor the amounts specified in the "Schedule of Compensation" attached hereto as Exhibit "C" and incorporated herein by this reference. The total compensation, including reimbursement for actual expenses, shall not exceed One Hundred and Twenty-One Thousand, Eight Hundred and Thirteen Dollars (\$121,813) (the "Contract Sum"), unless additional compensation is approved pursuant to Section 1.10.

The original Agreement shall continue in full force and effect without revision. Dated: September 16, 2019.
